Change that works: enough support and challenge for you to risk a better future.



Specific

Residual

A gift that leaves all or a portion of your estate after debts, taxes, other bequests and fees.



Deferred

A gift that provides for relatives or friends during their lifetimes, but also benefits the Mission afterwards.

In making a bequest which will serve the people the Mission works with, we suggest your legal advisor use the following wording:

I give and bequeath to Methodist Mission
Southern the sum of \$_____ to fulfil its general charitable purposes, and direct that the receipt of the Mission shall be good and sufficient discharge to my Trustees. If at my death the Methodist Mission Southern no longer exists under that name, this legacy shall not fail but my trustees shall pay it to the charitable organisation which they consider most nearly fulfils the objects I intended to benefit.
